PEER-REVIEW AND PUBLICATION PROCESS

The journal adheres to a double-blind peer reviewing policy in which the identity of both the reviewer and author are concealed from both parties unless this proves impossible because of extensive self-citation or other identifying features in the text. The journal is published online biannually in July and December and covers the studies carried out within the field of Social Sciences.

Editorial Review Process: All manuscripts are reviewed initially by the **pre-editors** and only those papers that meet the scientific and editorial standards of the journal, and fit within the aims and scope of the journal, will be sent for outside review.

Peer Review Process: Each manuscript is reviewed by at least two referees. Authors might be requested to suggest the names, affiliations and contact information of two qualified but independent reviewers who may be suitable to serve as voluntarily. The recommended referees should come from different institutions. The Editors are under no obligation to use all or any of these individuals as reviewers. Please be aware of any conflicts of interest when recommending reviewers. Examples of conflicts of interest are included (but are not limited to) the below:

- The reviewer should have no prior knowledge of your submission.
- The reviewer should not have recently collaborated with any of the authors.
- Reviewer nominees from the same institution as any of the authors are not permitted.

Publication Process: The manuscripts sent to the journal by the authors are evaluated in terms of compliance with the journal template, similarity rate and compliance with the journal subject/scope at the **pre-editorial** stage. Editors may decide to accept or reject at this stage; In addition, the author can withdraw his publication at this stage. The work, which passes the preliminary controls, is taken to the publication evaluation stage. The work is peer-reviewed by at least 2 referees. As a result of the reviewers' evaluations, the author of the manuscript must make the necessary corrections within 15 days. The work that makes the corrections given by the reviewer and receives positive feedback is included in the publication process. The work is re-examined by the editors and technical editors within the framework of grammar and spelling rules, and is taken into layout processes for publication. At the last stage, the approval for publication is obtained from the author of the work and sent for publication. The journal publishes 2 issues per year. The process of acceptance and publication of the publication takes between 3-4 months with the first application of the author.

For the authors, the followings steps are followed:

- Authors read the pages within "Author Guidelines" menu carefully.
- Authors ensure that they are submitting to the most suitable journal and your manuscript is accurate and readable.
- Authors submit their manuscripts within "**Submit an Article**" link.
- After the manuscript is uploaded to the system, the relevant information is given to the author(s) by e-mail.
- First, manuscripts are reviewed initially at the **pre-editorial** stage. The papers, which pass the preliminary controls, are taken to the publication evaluation stage
- Manuscript are checked through plagiarism checkers. (*iThenticate*) If the manuscript has a similarity rate of more than %20, authors are informed that the paper is rejected.
- When the article is found suitable in terms of form and content, it is sent to the members of the Scientific Board and Reviewers for double-blind peer-review process. The paper is peer-reviewed by at least 2 referees.
- Based on double blinded peer review reports, editors take decision to accept or reject the paper or editor can take decision of re-submission of manuscript after suggested changes. If the article is accepted after the final evaluation, an e-mail is sent to the author within a few days regarding the acceptance of the paper.
- It is foreseen that the whole process will be completed within a period of 3-4 months.
- All the details about the publication and peer-review is explained within the,
 Article Submission and Publication Workflow.

ARTICLE PROCESSING CHARGE

UTISGAD **does not charge** for any article submissions or for processing. The publication costs for *International Journal of Commerce, Industry and Entrepreneurship Studies* (*Utisgad Journal*) are covered by Silifke Chamber of Commerce and Industry (SITSO) so **authors do not need to pay any article-processing & publication charge.**

ARTICLE SUBMISSION PROCESS

The journal accepts the papers only through the article submission system. Article Submission Process should be read by the authors carefully. It is recommended to out the **Article Submission and Publication Workflow.**

PRESERVATION POLICY

Published articles of Utisgad Journal are deposited both in **Turkish National Library**, **Silifke Chamber of Commerce and Industry servers** and **Utisgad Journal Archive System** in terms of long-term preservation of the articles. Digital preservation involves a series of processes and actions designed to ensure the long-term accessibility and dissemination of information currently available in digital formats. The preservation policy of Utisgad Journal comprises the following strategies:

 Website Archiving: All electronic content, including website content and manuscripts, is stored in different locations. The primary server hosts the content online and allows readers to access it. Simultaneously, a backup of the same content is preserved on other servers. In the event of a server failure, these alternative resources can be activated, and the website is expected to be available again within 2 hours.

- 2. **Abstracting/Indexing Services:** The journal's Abstracting/Indexing services retain crucial information about articles. Additionally, some of these services also archive metadata and electronic versions of the articles. This enables the scientific community to access copies of the articles through these systems as an alternative to traditional journals. PUBLICATION ETHICS

The ethics and rules defined by editorial committee of International Journal of Commerce, Industry and Entrepreneurship Studies (Utisgad Journal) is based on *rules* defined by Committee on Publication Ethics. In this context, it is expected to follow the instructions explained below and take the responsibility account from all stakeholders of the journal:

Editors' Ethical Responsibilities

- Editors should respect intellectual property rights while evaluating works and should strive for qualified and rapid progress of the evaluation and publication processes of the work.
- The process steps of the work evaluation processes should be published openly and transparently.
- It should be ensured that the process of evaluation and publication of the work is qualified and fast.
- Editors should appoint referees impartially in accordance with scientific evaluation principles and provide an environment of free thought.

- It is expected that the journal will bring together many academicians who are experts in different fields, and that the editors will expand the scientific committee pool of the journal by reaching these academics and inviting them to the journal.
- In order to make the work of the authors easier in the publication process in the journal, the editors should share a list containing the writing rules of the journal.
- Every step in the evaluation process of the work sent to the journal should be shared with the owner of the work. When a positive or negative decision is made about the work, this information should be shared with the owner of the work in detail and scientifically evaluated.
- In accordance with the principle of double-blind peer refereeing, the names and information of the authors and referees should be kept confidential and should not be shared.

Reviewers' Ethical Responsibilities

- Reviewers should accept peer-reviewing the studies that fall within their field of study and expertise. In order to the evaluation to be carried out effectively and accurately, it is very important that the reviewers accept the peer-review for the works that they trust in their competence.
- In accordance with the principle of blind peer-review process, reviewers must keep their identities confidential. In addition, the reviewers should not reach information about the owners of the works they evaluate; otherwise, they should not evaluate the works of which they have knowledge about their authors, or they should terminate the task regarding the evaluated work and immediately contact the editors.
- The stages in the evaluation process must be completed within the given time.
- Reviewers are expected to approach the works they evaluate with an impartial and unbiased perspective.
- At the end of the evaluation, the reviewers should share their reports which they prepared in a scientific and explanatory language with the editors.

Authors' Ethical Responsibilities

- Authors confirm that the submission has been submitted solely here and is not published, in press, or submitted elsewhere.
- Authors confirm that all the research meets the ethical guidelines, including adherence to the legal requirements of the study country.
- Authors confirm that they have prepared a complete text minus the title page, acknowledgements, and any running headers with author names, to allow blinded review.
- Authors confirm that submission hasn't been submitted previously.

- Authors confirm that ethical standards for publication exist to ensure high-quality scientific publications, public trust in scientific findings, and that people receive credit for their ideas.

It is important to avoid:

- **Data fabrication and falsification:** Data fabrication means the researcher did not actually do the study but faked the data. Data falsification means the researcher did the experiment, but then changed some of the data.
- **Plagiarism:** Taking the ideas and work of other scientists without giving them credit is unfair and dishonest. Copying even one sentence from someone else's manuscript, or even one of your own that has previously been published, without proper citation is considered plagiarism—use your own words instead.
- Multiple submissions: It is unethical to submit the same manuscript to more than
 one journal at the same time. Doing this wastes the time of editors and peer
 reviewers and can damage the reputation of the authors and the journals if
 published in more than one journal as the later publication will have to be
 retracted.
- **Redundant publications:** This means publishing many very similar manuscripts based on the same experiment. Combining your results into one very robust paper is more likely to be of interest to a selective journal. Editors are likely to reject a weak paper that they suspect is a result of salami slicing.
- Improper author contribution or attribution: All listed authors must have made a significant scientific contribution to the research in the manuscript and approved all its claims. Don't forget to list everyone who made a significant scientific contribution, including students and laboratory technicians. Do not "gift" authorship to those who did not contribute to the paper.

Publisher's Responsibilities:

- Utisgad Journal provides free-online access to its contents. All stakeholders of the journal are independent of the publisher, and all processes related to publication are carried out independently of the publisher.
